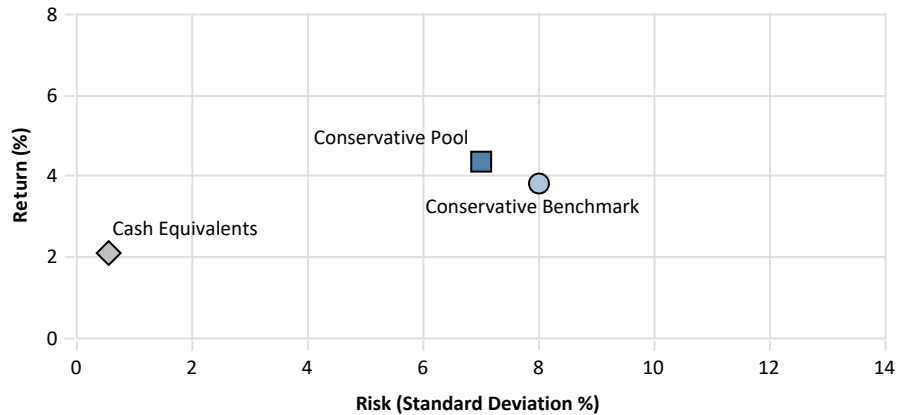

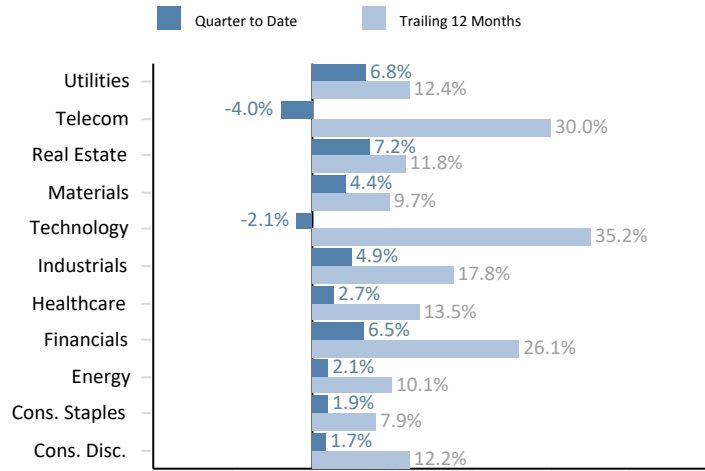

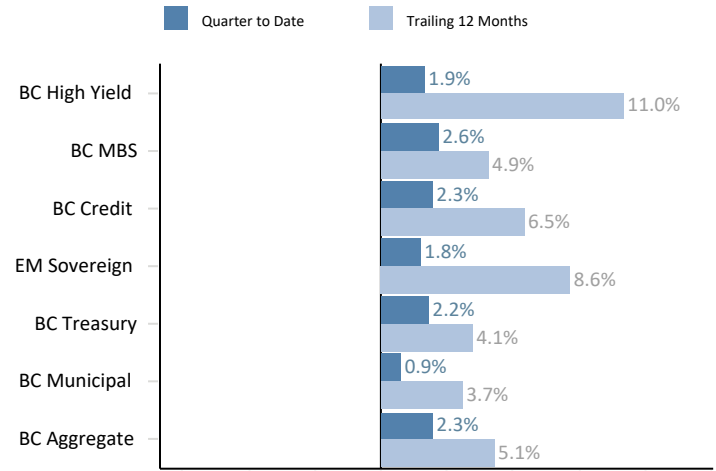
Closing the books on the first half, the S&P 500 Index sits just below another all-time high following its 12th best start to a year since 1950. Given precedent around trend persistence, especially in presidential election years, this suggests a sanguine full-year outlook. But this bull run, like this economic cycle, is atypical in so many ways that forecasting with confidence borders dangerously on hubris.

Consider that the aggregate headline of the US economy continues to suggest robust nominal GDP growth, reasonably low unemployment, positive real income growth and slowly declining inflation; yet two-thirds of consumers and most small businesses are exhibiting signs of stress and weak confidence. While new and existing home sales are falling, the average price is still rising more than 6% per year, and owner-occupied rents have failed to decline. Despite 550 basis points of rate hikes and more than \$1 trillion in quantitative tightening, US financial conditions remain as accommodative as ever, raising genuine questions about the policy transmission mechanism and whether the Federal Reserve really has control in a world characterized by extreme wealth concentration, shadow banking and fiscal predominance. Equally perplexing, rarely have markets been so expensive - absolutely and relative to US Treasuries - or so disconnected from economic surprises and the level and direction of interest rates. Rarely has a bull market experienced such an uninterrupted string of all-time highs amid severely deteriorating breadth and limited participation from small-cap stocks.

Meanwhile, the S&P 500 index gained 4.29 over the same period as five S&P 500 sectors posted gains and six sectors experienced price declines over the quarter.

The Russell Midcap declined -3.34% in the quarter, as Mid-cap Growth declined -3.21% and Mid-cap Value declined -3.27%. The Russell 2000 Small-cap index declined -3.27% for the quarter, as small-cap value declined -3.64% and small-cap growth declined -2.92%.

The MSCI ACWI (a global equity index containing large and mid-cap stocks in 23 developed and 24 emerging markets) rose 2.87% for US-currency investors.

The Fed continued its rate policy pause through the end of the first quarter. Since March 2022, the Fed announced eleven rate hikes, for a total of 5.25 percentage points. The yield on the 10-year Treasury note closed the second quarter at 4.4%, up from 4.2% at the end of the first quarter. The yield on 3-month Treasury bills was 5.4%, up from 5.3% at the end of the first quarter. The Bloomberg US Aggregate Bond index rose 0.07% in 2Q24 after posting a -0.78% return in 1Q24.

The Bloomberg US Corporate High Yield Index increased 1.1%. The Bloomberg US Long Government ended the quarter down -1.73%

The Bloomberg Mortgage-Backed Securities Index declined rose 0.1%, while the Bloomberg Municipal Bond Index held flat.

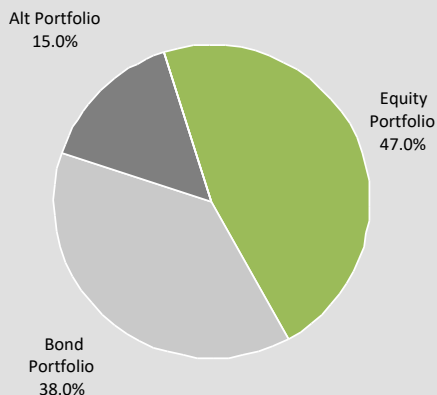

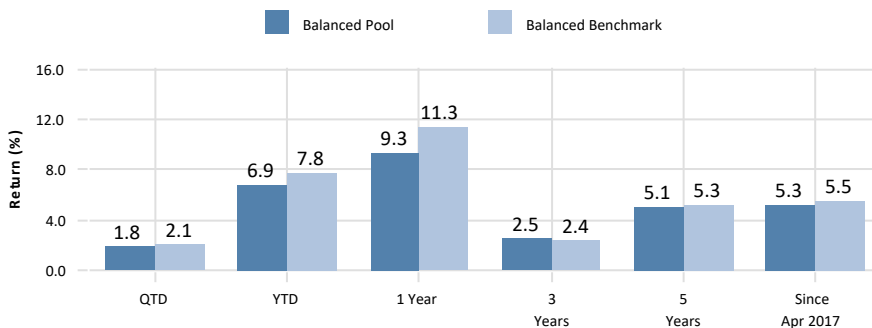

Target Asset Allocation



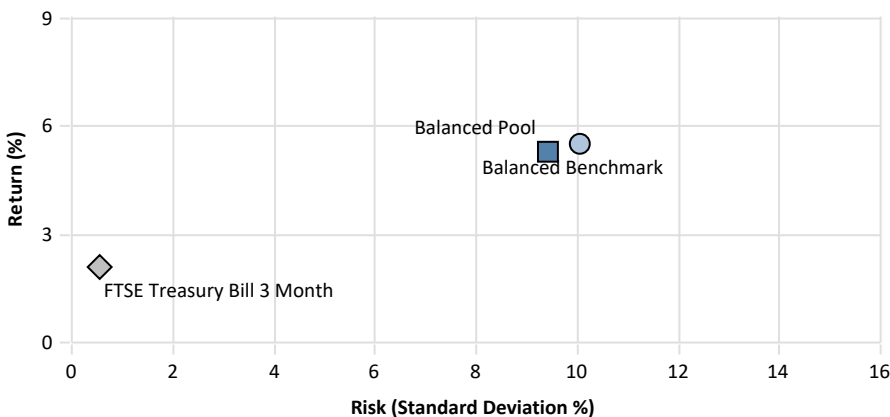

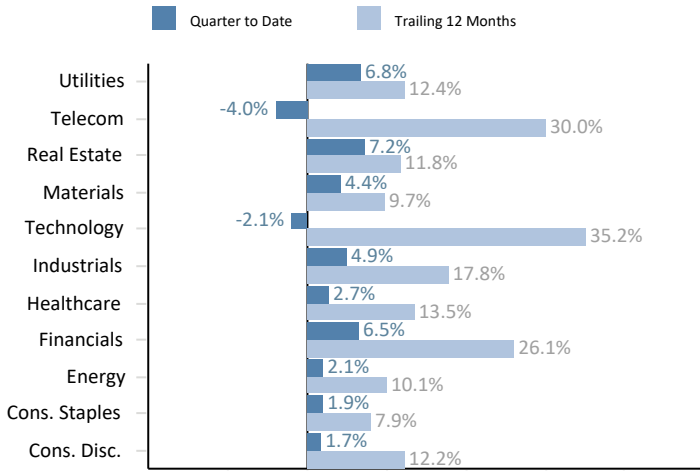

Target Asset Allocation

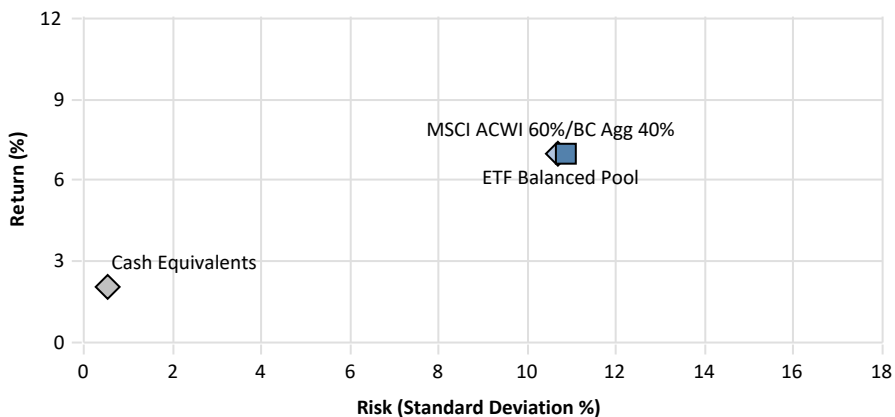

Target Asset Allocation



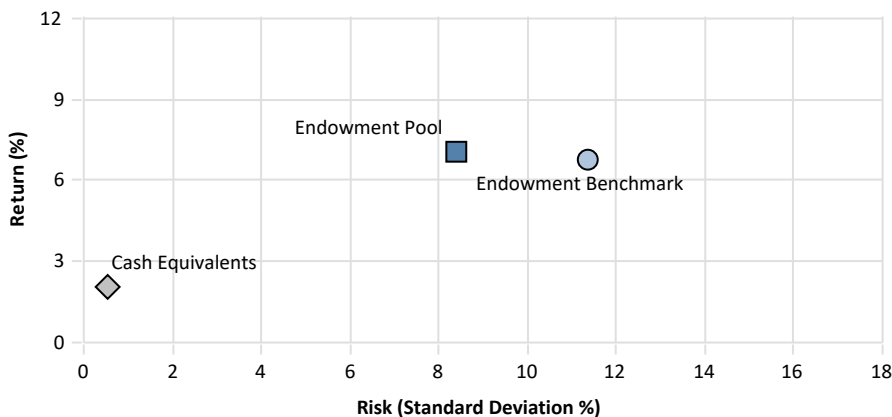

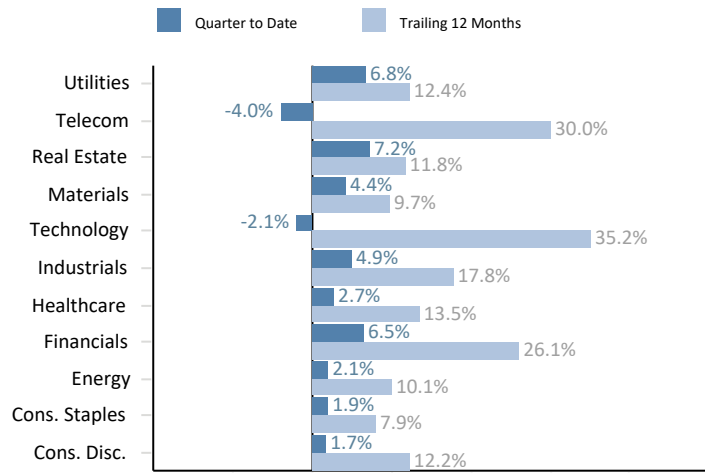

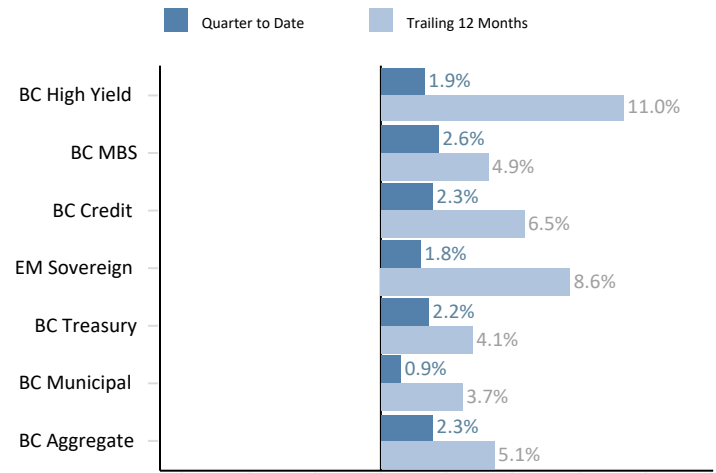

Given precedent around trend persistence, especially in presidential election years, this suggests a sanguine full-year outlook. But this bull run, like this economic cycle, is atypical in so many ways that forecasting with confidence borders dangerously on hubris.

Consider that the aggregate headline of the US economy continues to suggest robust nominal GDP growth, reasonably low unemployment, positive real income growth and slowly declining inflation; yet two-thirds of consumers and most small businesses are exhibiting signs of stress and weak confidence. While new and existing home sales are falling, the average price is still rising more than 6% per year, and owner-occupied rents have failed to decline. Despite 550 basis points of rate hikes and more than \$1 trillion in quantitative tightening, US financial conditions remain as accommodative as ever, raising genuine questions about the policy transmission mechanism and whether the Federal Reserve really has control in a world characterized by extreme wealth concentration, shadow banking and fiscal predominance. Equally perplexing, rarely have markets been so expensive - absolutely and relative to US Treasuries - or so disconnected from economic surprises and the level and direction of interest rates. Rarely has a bull market experienced such an uninterrupted string of all-time highs amid severely deteriorating breadth and limited participation from small-cap stocks.

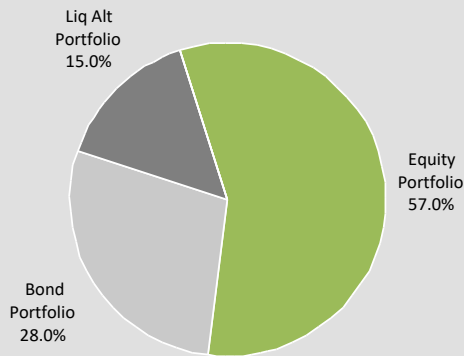

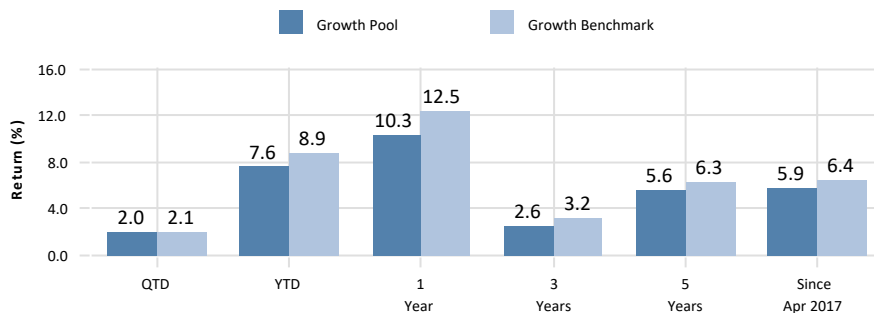

Target Asset Allocation



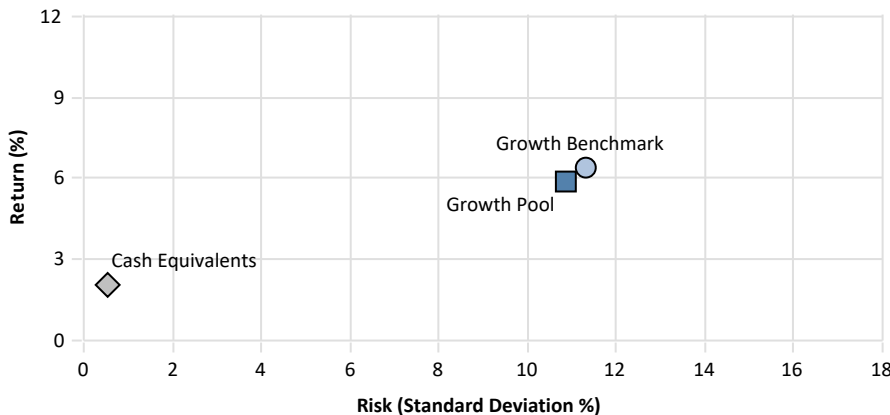

Target Asset Allocation

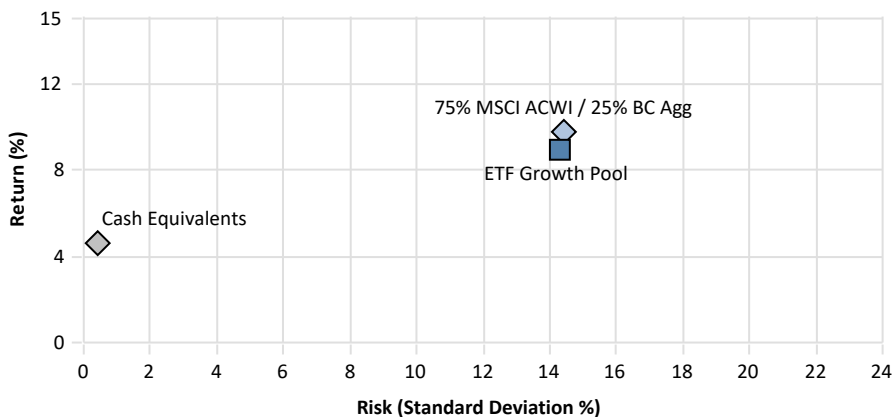

While new and existing home sales are falling, the average price is still rising more than 6% per year, and owner-occupied rents have failed to decline. Despite 550 basis points of rate hikes and more than \$1 trillion in quantitative tightening, US financial conditions remain as accommodative as ever, raising genuine questions about the policy transmission mechanism and whether the Federal Reserve really has control in a world characterized by extreme wealth concentration, shadow banking and fiscal predominance. Equally perplexing, rarely have markets been so expensive - absolutely and relative to US Treasuries - or so disconnected from economic surprises and the level and direction of interest rates. Rarely has a bull market experienced such an uninterrupted string of all-time highs amid severely deteriorating breadth and limited participation from small-cap stocks.

Target Asset Allocation



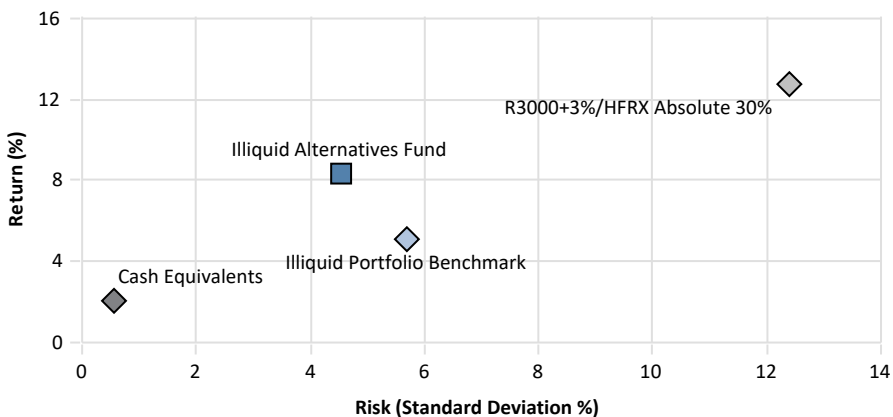

Target Asset Allocation

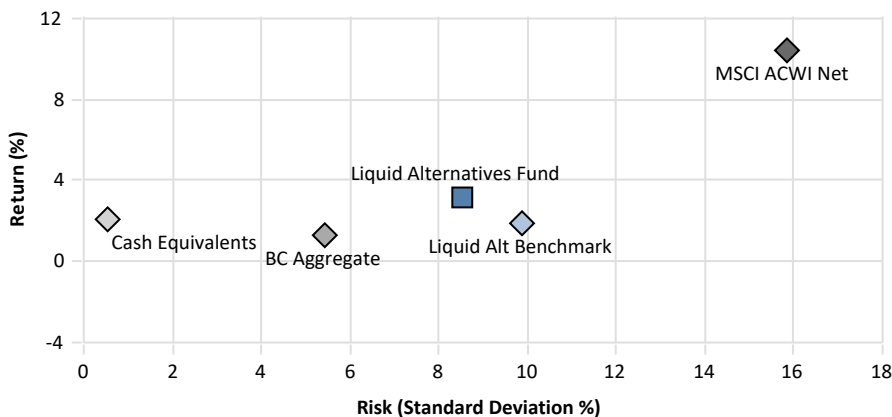

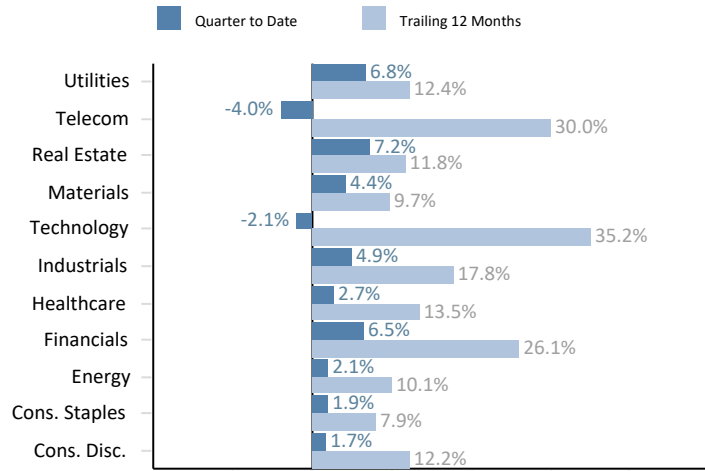

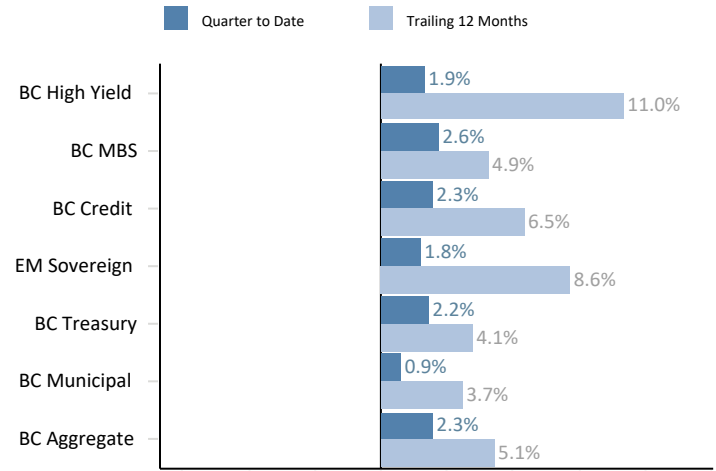

Given precedent around trend persistence, especially in presidential election years, this suggests a sanguine full-year outlook. But this bull run, like this economic cycle, is atypical in so many ways that forecasting with confidence borders dangerously on hubris.

Consider that the aggregate headline of the US economy continues to suggest robust nominal GDP growth, reasonably low unemployment, positive real income growth and slowly declining inflation; yet two-thirds of consumers and most small businesses are exhibiting signs of stress and weak confidence. While new and existing home sales are falling, the average price is still rising more than 6% per year, and owner-occupied rents have failed to decline. Despite 550 basis points of rate hikes and more than \$1 trillion in quantitative tightening, US financial conditions remain as accommodative as ever, raising genuine questions about the policy transmission mechanism and whether the Federal Reserve really has control in a world characterized by extreme wealth concentration, shadow banking and fiscal predominance. Equally perplexing, rarely have markets been so expensive - absolutely and relative to US Treasuries - or so disconnected from economic surprises and the level and direction of interest rates. Rarely has a bull market experienced such an uninterrupted string of all-time highs amid severely deteriorating breadth and limited participation from small-cap stocks.

The Bloomberg US Corporate High Yield Index increased 1.1%. The Bloomberg US Long Government ended the quarter down -1.73%

The Bloomberg Mortgage-Backed Securities Index declined rose 0.1%, while the Bloomberg Municipal Bond Index held flat.

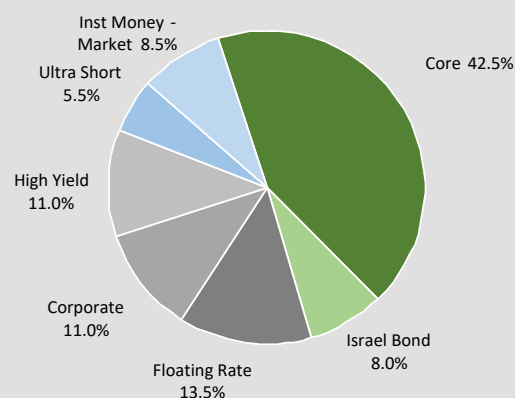

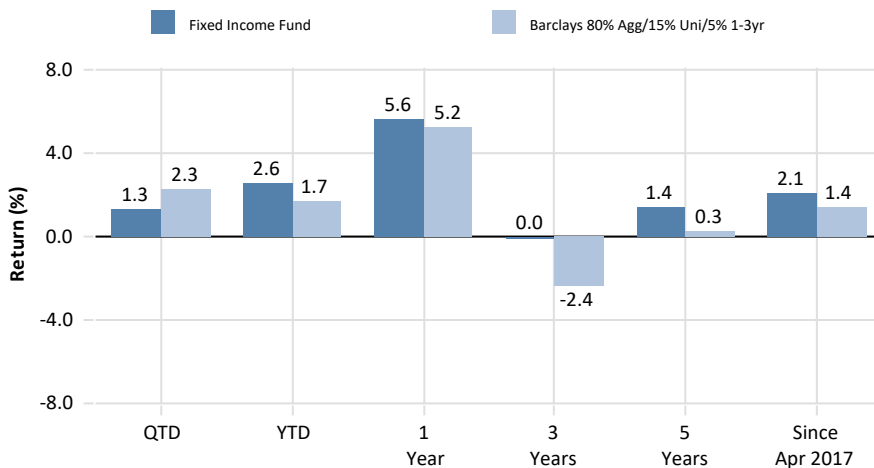

Target Asset Allocation

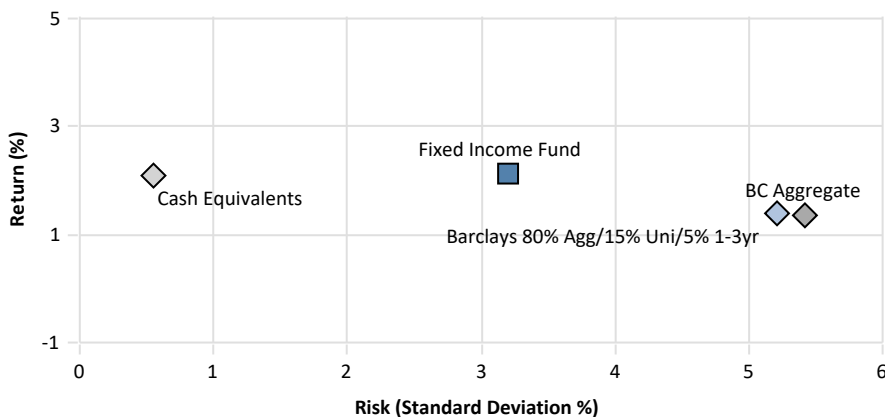

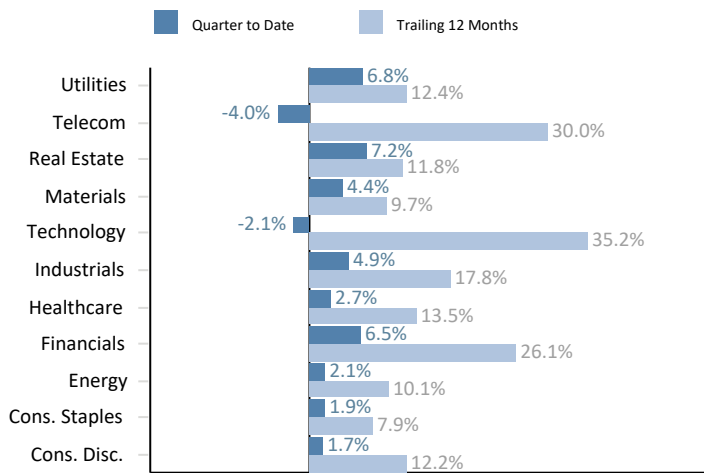

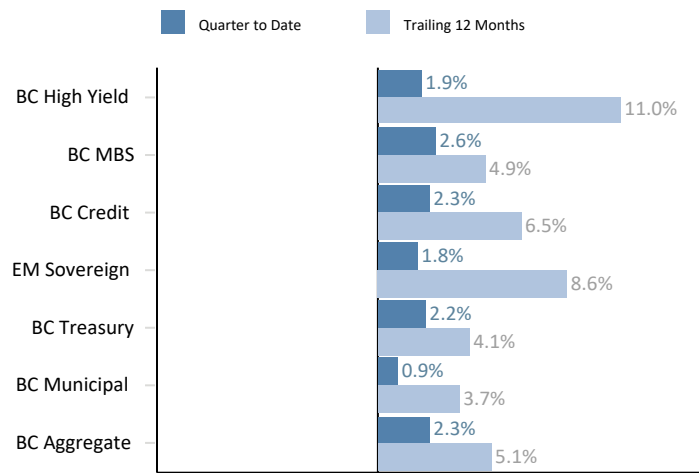

Peer Group Ranking Methodology

A percentile rank denotes the value of a product in which a certain percent of observations fall within a peer group. The range of percentile rankings is between 1 and 100, where 1 represents a high statistical value and 100 represents a low statistical value.

The 30th percentile, for example, is the value in which 30% of the highest observations may be found, the 65th percentile is the value in which 65% of the highest observations may be found, and so on.

Percentile rankings are calculated based on a normalized distribution ranging from 1 to 100 for all products in each peer group, where a ranking of 1 denotes a high statistical value and a ranking of 100 denotes a low statistical value. It is important to note that the same ranking methodology applies to all statistics, implying

that a ranking of 1 will always mean highest value across all statistics.
