Target Asset Allocation

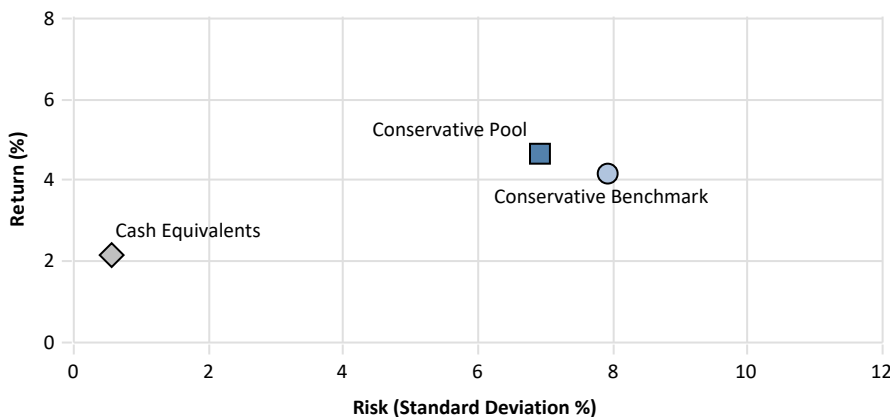

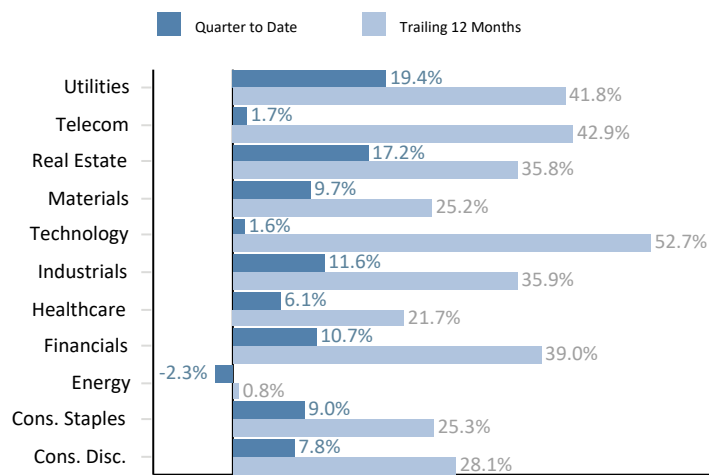


Market Commentary

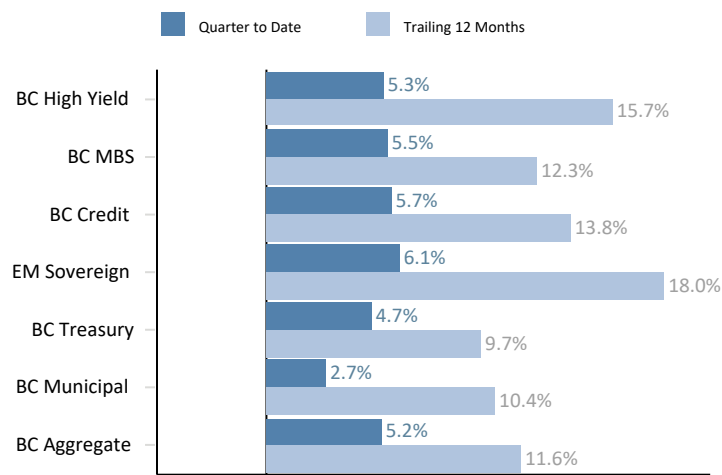
The third quarter ended with the S&P 500 index up more than 20% on the year and 5% on the quarter, and within a few points of the 5,767 all-time high-a level that, based on consensus estimates, has it selling at a rich forward P/E ratio of 22.3 times. But after a first half featuring a great deal of anticipation around an impending Federal Reserve easing cycle and performance concentration in a handful of megacap tech names, the third quarter marked a notable departure.

Not only did the Nasdaq Composite Index and the "Magnificent Seven" peak on July 10, as Fed cuts finally came into view on improving inflation, but since then, market breadth has been excellent. Enthusiasm for an "immaculate soft landing," or nonrecessionary slowing that does not harm the labor market in 2025, has been heightened by the start of Fed easing with a front-loaded 50bps rate cut. While this accommodation and further cuts already discounted by markets-an aggressive 175 to 200bps by January 2026-may be enough to rescue the economy, investor attention is directed towards the next phase of this nominal bull market.

Meanwhile, the S&P 500 index gained 5.9% over the same period as ten S&P 500 sectors posted gains and one sector experienced price declines over the quarter.

The Russell Midcap gained 9.2% in the quarter, as Mid-cap Growth increased 6.5% and Mid-cap Value grew 10.1%. The Russell 2000 Small-cap index gained 9.3% for the quarter, as small-cap value increased 10.1% and small-cap growth rose 8.4%.

The yield on the 10-year US Treasury note closed the third quarter at 3.78%, down from the 4.40% at the end of Q2, while the yield on 3-month Treasury bills was 4.62%, down from 5.36% at the end of the second quarter.

The Bloomberg US Corporate High Yield Index increased 5.3%. The Bloomberg US Long Government ended the quarter up 8.0%.

The Bloomberg Mortgage-Backed Securities Index rose 5.5%, while the Bloomberg Municipal Bond Index increased by 2.7%.

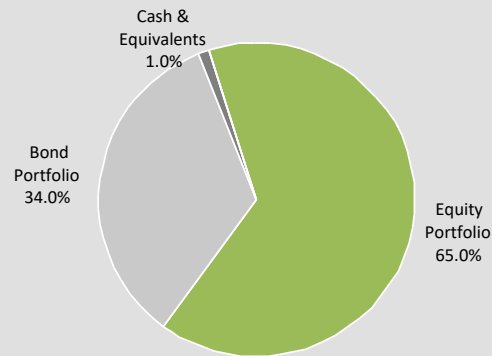

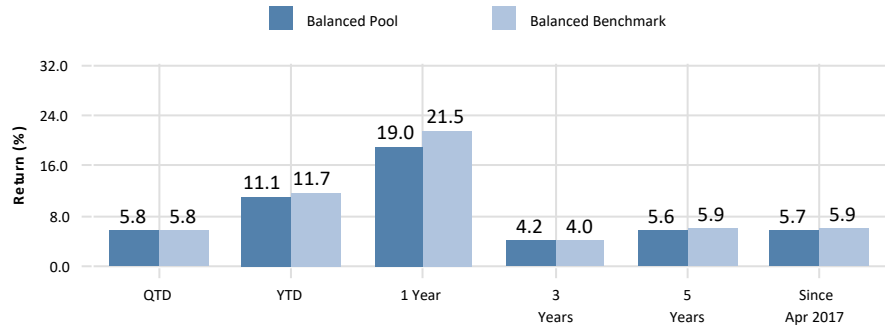

Target Asset Allocation



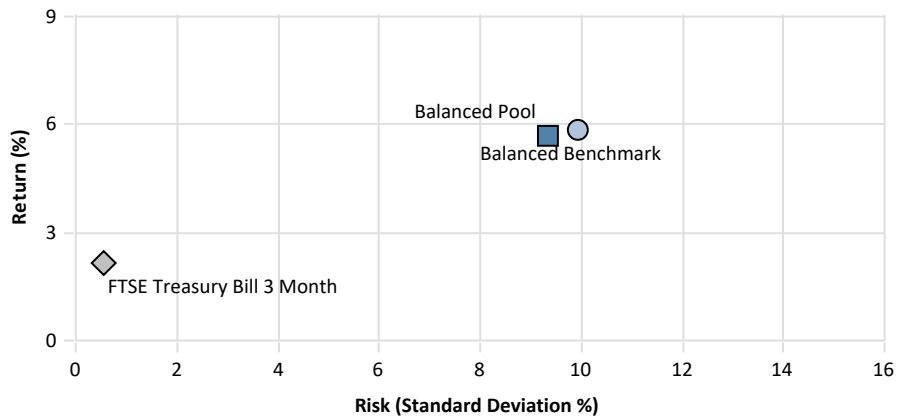

Target Asset Allocation

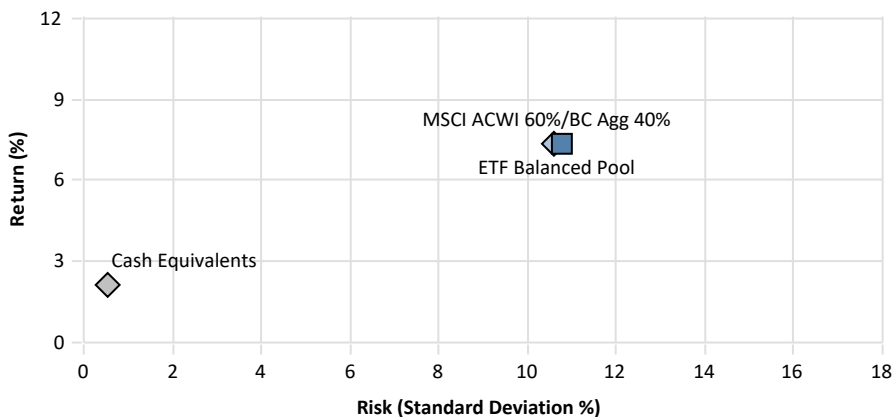

Target Asset Allocation



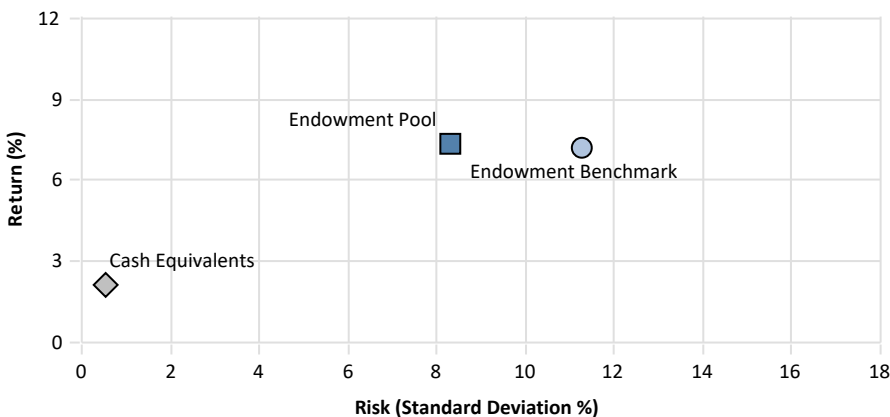

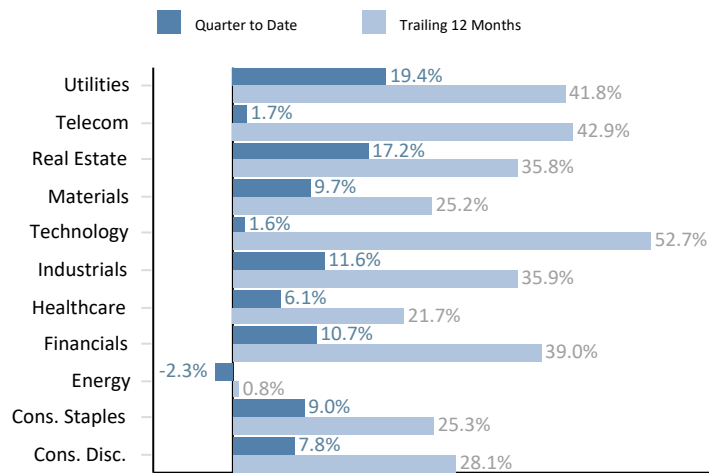

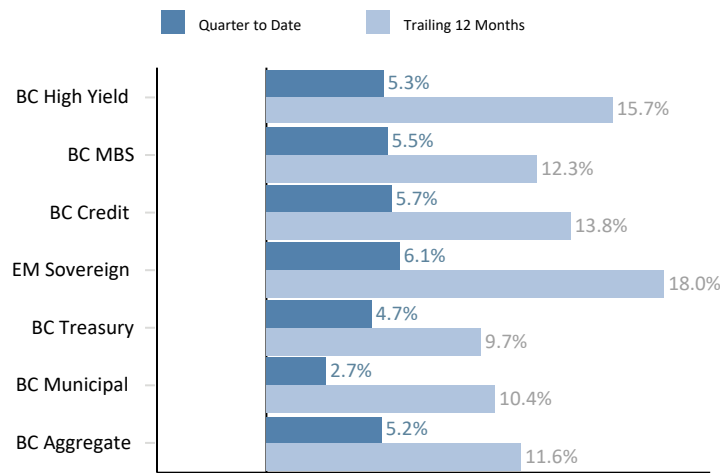

Enthusiasm for an "immaculate soft landing," or nonrecessionary slowing that does not harm the labor market in 2025, has been heightened by the start of Fed easing with a front-loaded 50bps rate cut. While this accommodation and further cuts already discounted by markets-an aggressive 175 to 200bps by January 2026-may be enough to rescue the economy, investor attention is directed towards the next phase of this nominal bull market.

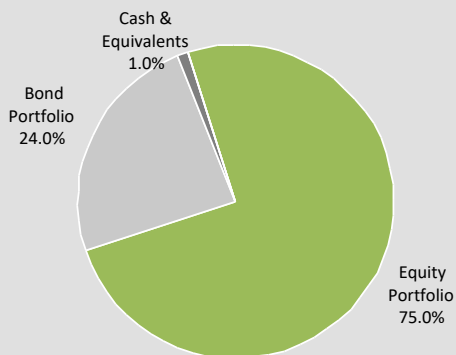

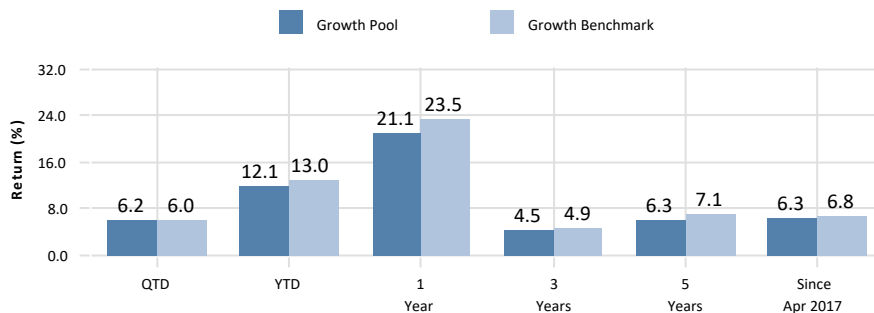

Target Asset Allocation



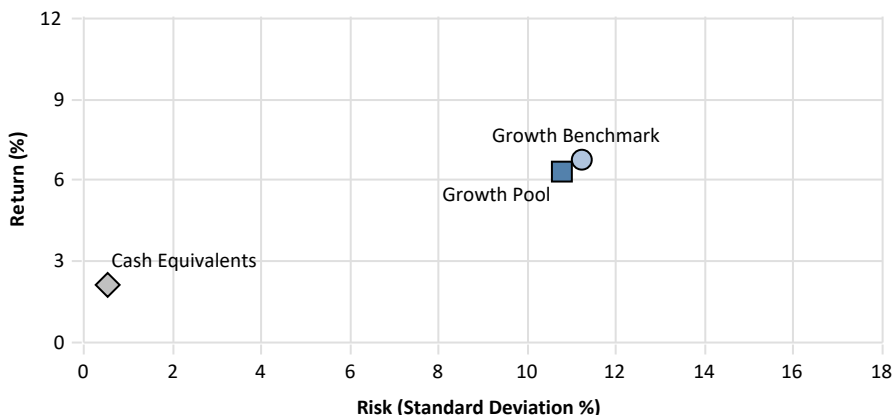

Target Asset Allocation

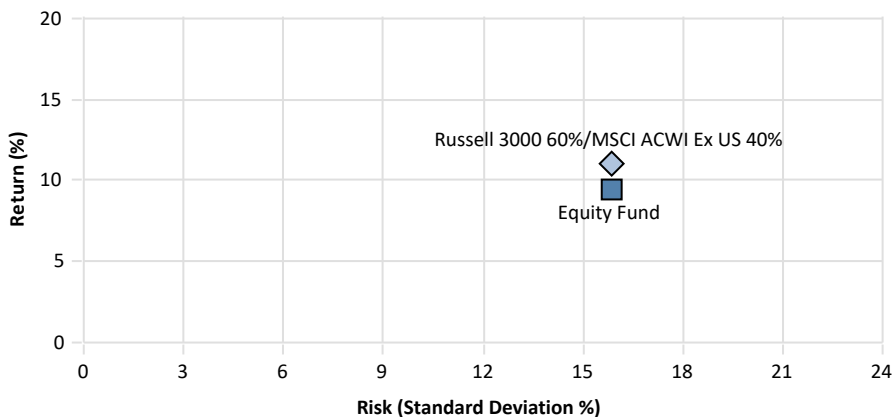

Target Asset Allocation

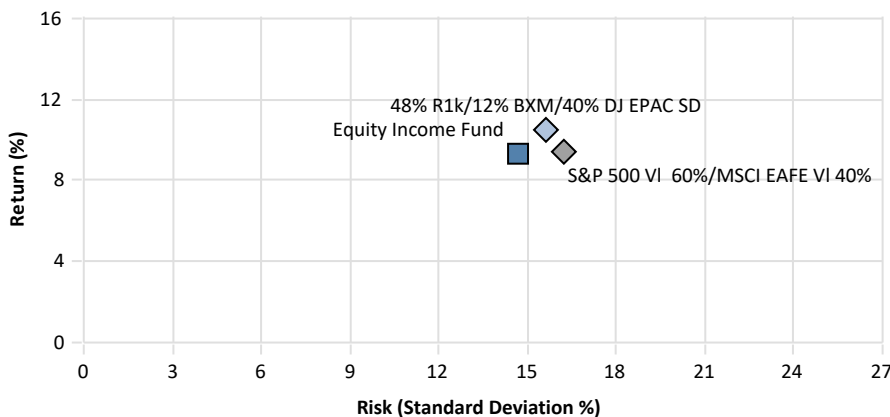

Target Asset Allocation



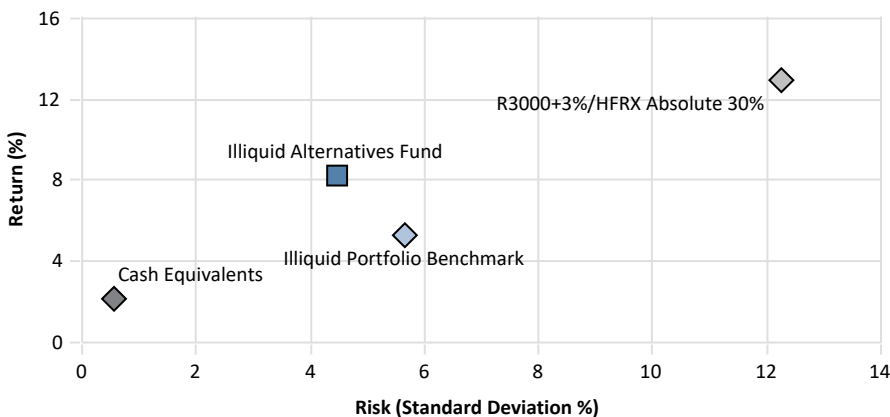

Target Asset Allocation



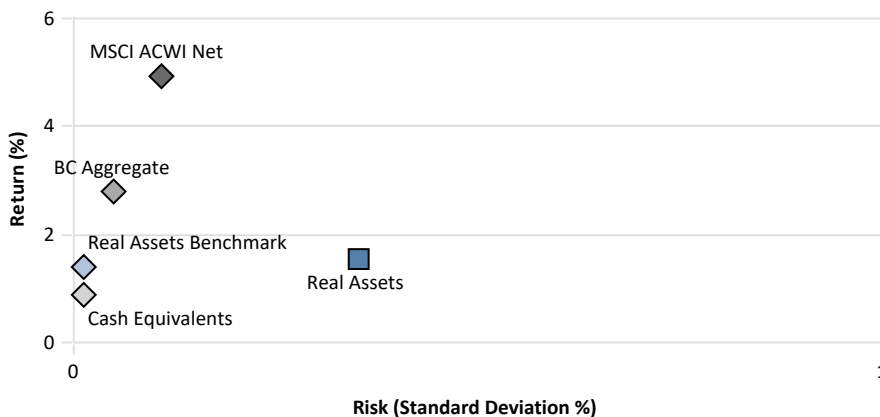

Target Asset Allocation

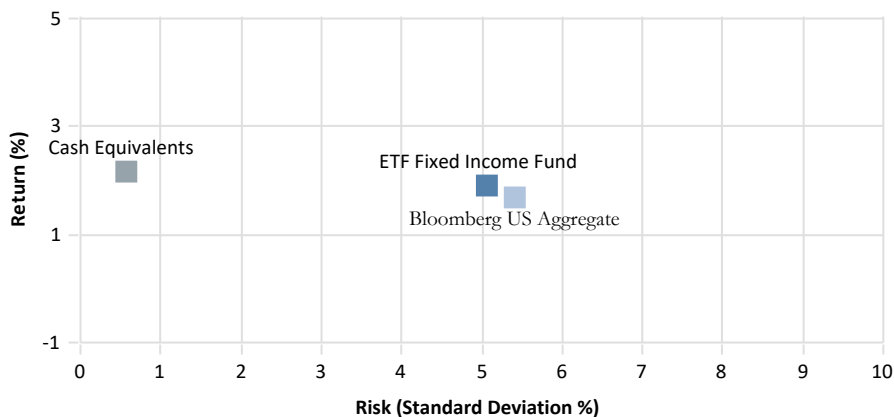

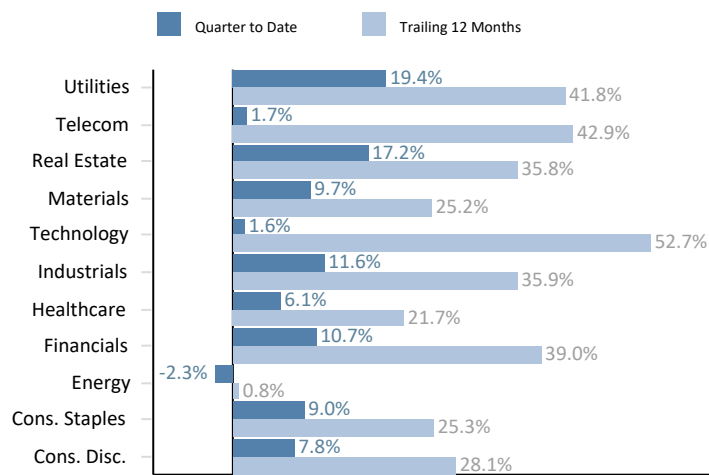

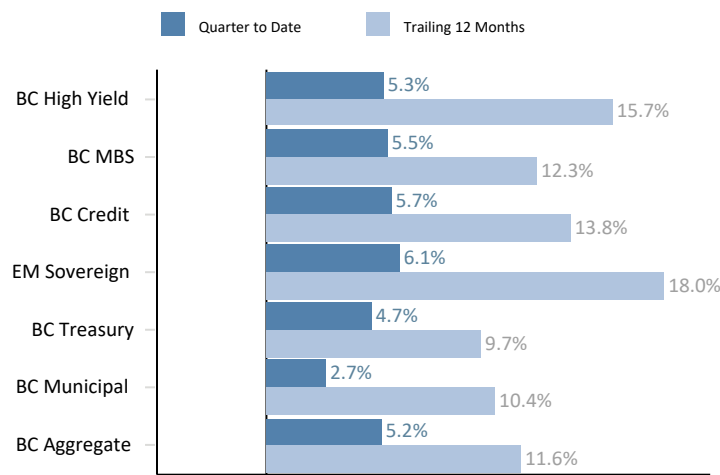
The third quarter ended with the S&P 500 index up more than 20% on the year and 5% on the quarter, and within a few points of the 5,767 all-time high-a level that, based on consensus estimates, has it selling at a rich forward P/E ratio of 22.3 times. But after a first half featuring a great deal of anticipation around an impending Federal Reserve easing cycle and performance concentration in a handful of megacap tech names, the third quarter marked a notable departure.

Not only did the Nasdaq Composite Index and the "Magnificent Seven" peak on July 10, as Fed cuts finally came into view on improving inflation, but since then, market breadth has been excellent. Enthusiasm for an "immaculate soft landing," or nonrecessionary slowing that does not harm the labor market in 2025, has been heightened by the start of Fed easing with a front-loaded 50bps rate cut. While this accommodation and further cuts already discounted by markets-an aggressive 175 to 200bps by January 2026-may be enough to rescue the economy, investor attention is directed towards the next phase of this nominal bull market.

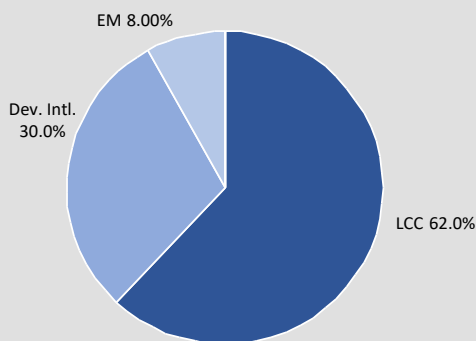

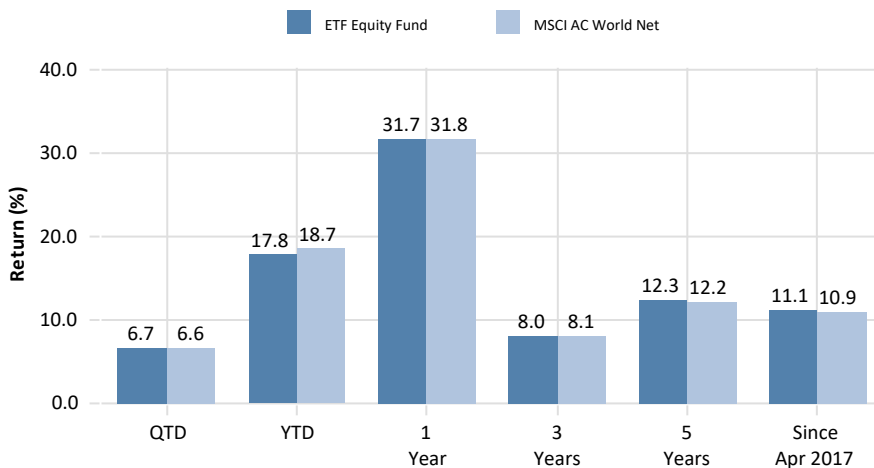

Target Asset Allocation

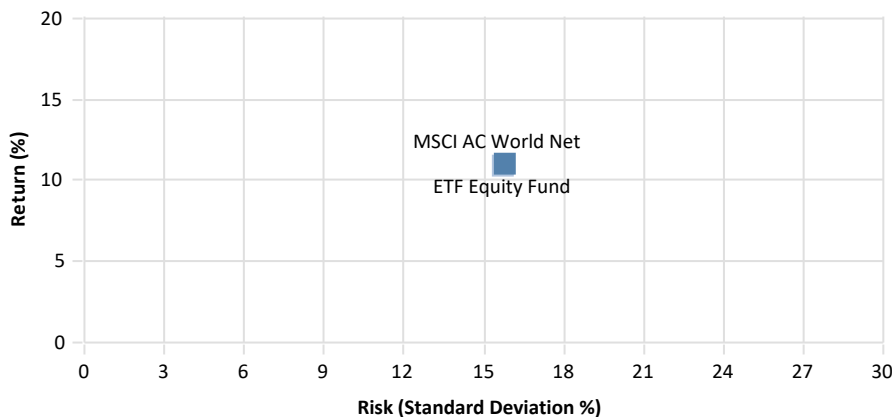

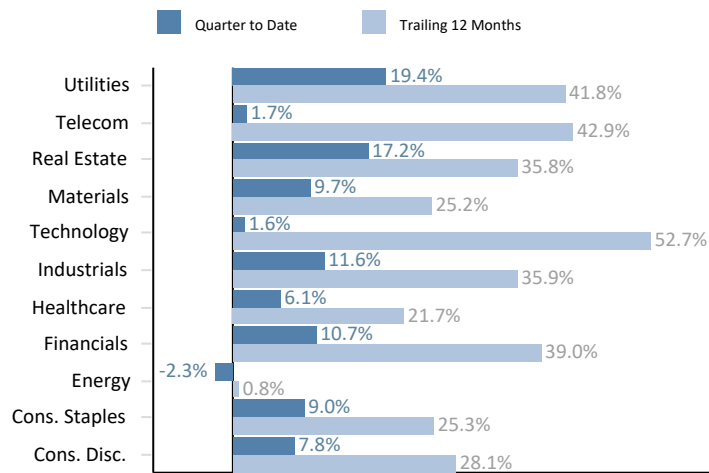

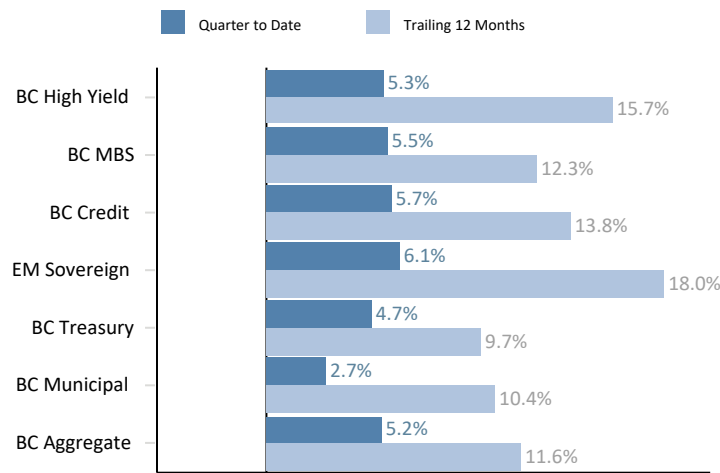

Peer Group Ranking Methodology

A percentile rank denotes the value of a product in which a certain percent of observations fall within a peer group. The range of percentile rankings is between 1 and 100, where 1 represents a high statistical value and 100 represents a low statistical value.

The 30th percentile, for example, is the value in which 30% of the highest observations may be found, the 65th percentile is the value in which 65% of the highest observations may be found, and so on.

Percentile rankings are calculated based on a normalized distribution ranging from 1 to 100 for all products in each peer group, where a ranking of 1 denotes a high statistical value and a ranking of 100 denotes a low statistical value. It is important to note that the same ranking methodology applies to all statistics, implying

that a ranking of 1 will always mean highest value across all statistics.
