Target Asset Allocation

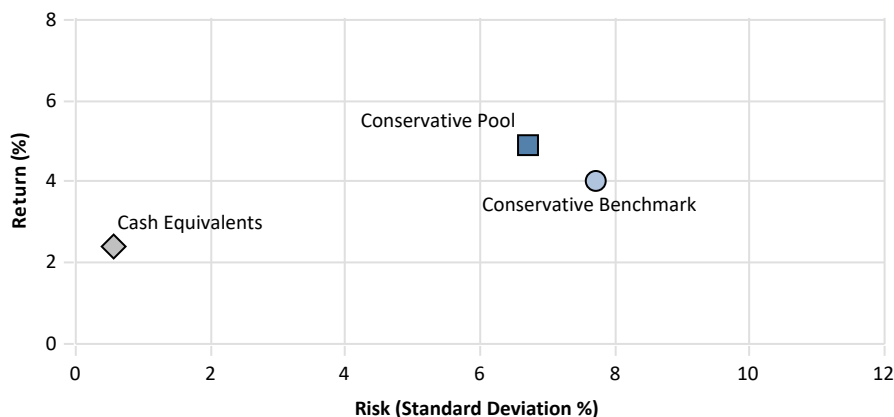

Target Asset Allocation



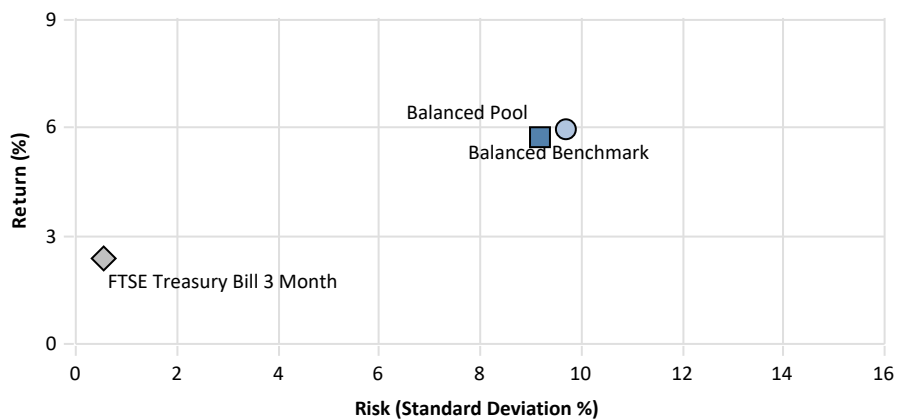

Target Asset Allocation

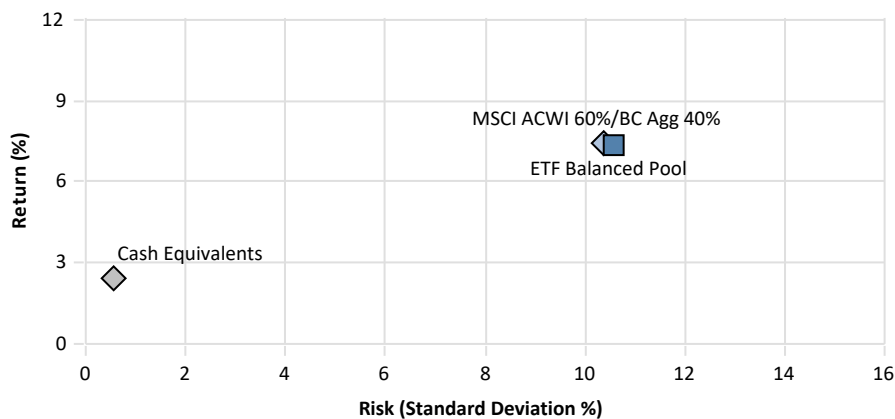

Target Asset Allocation



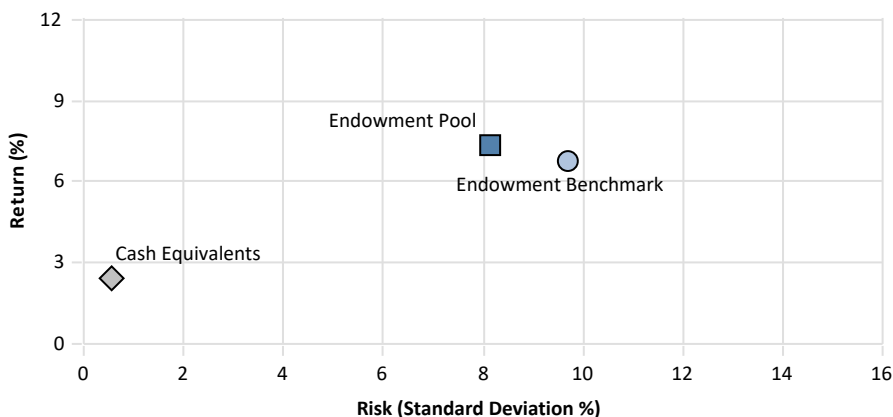

Target Asset Allocation



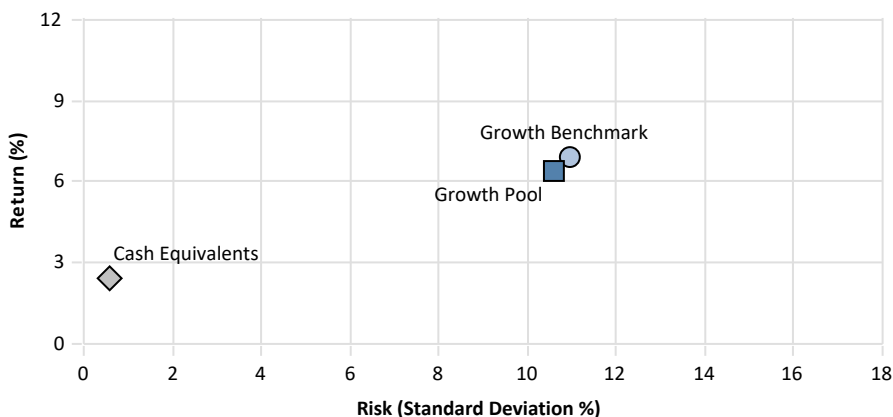

Target Asset Allocation

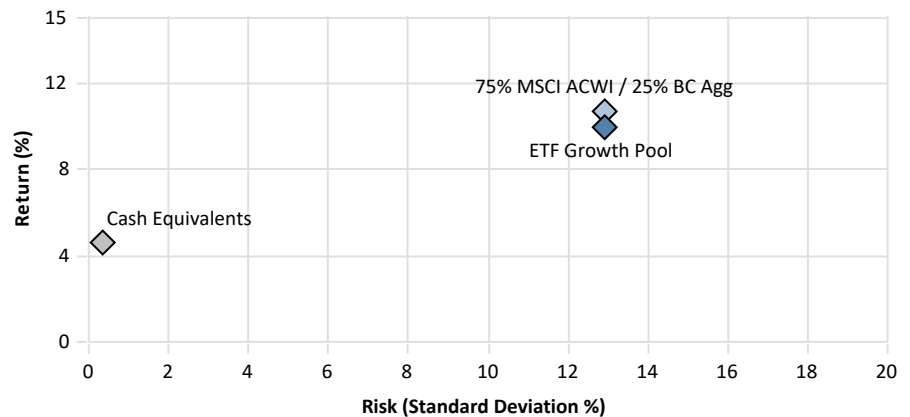

Target Asset Allocation

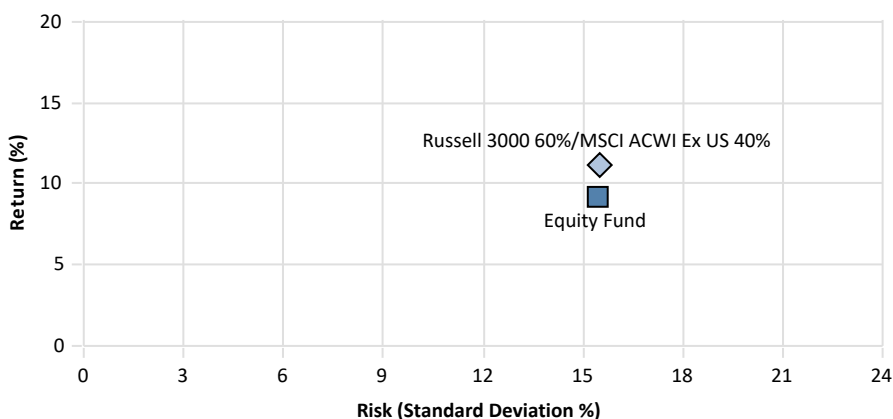

Target Asset Allocation



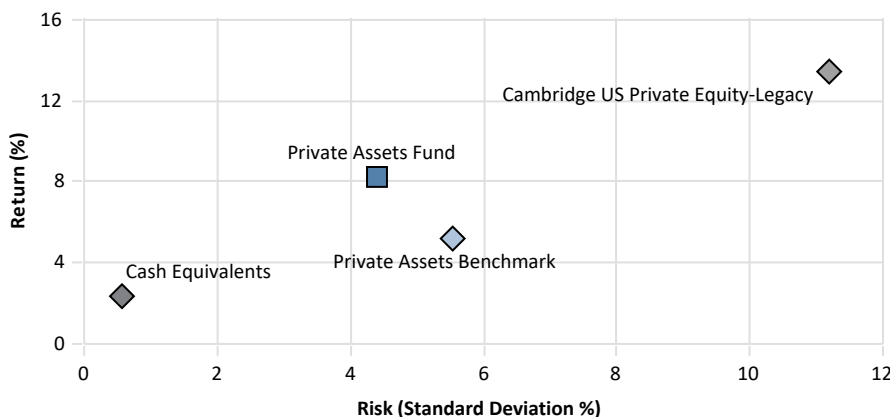

Target Asset Allocation



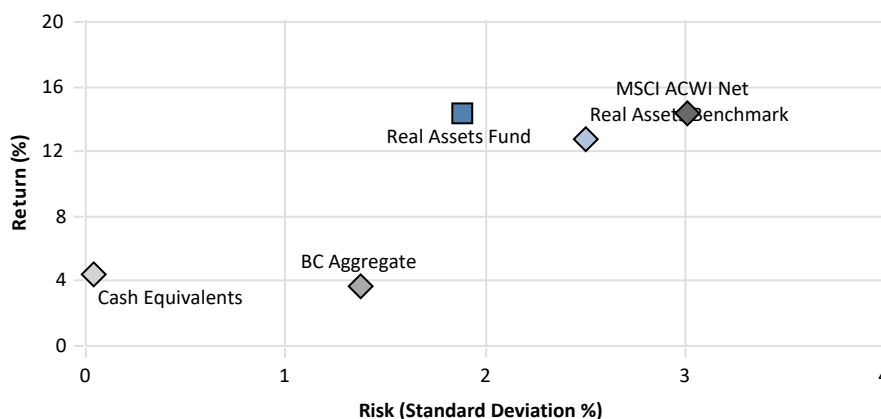

Target Asset Allocation

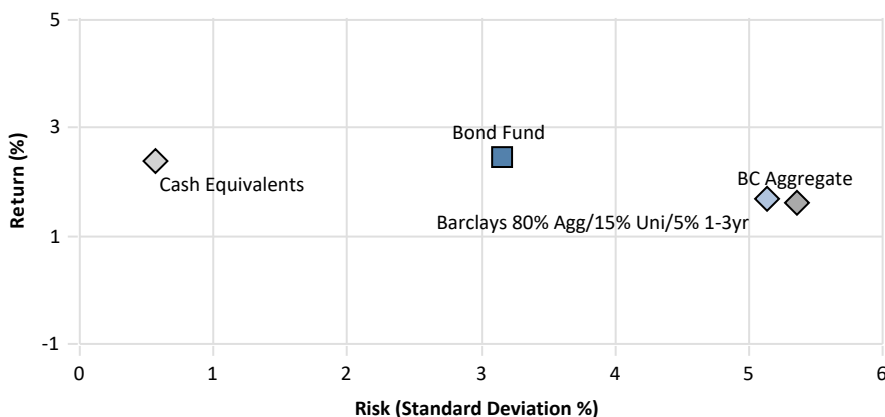

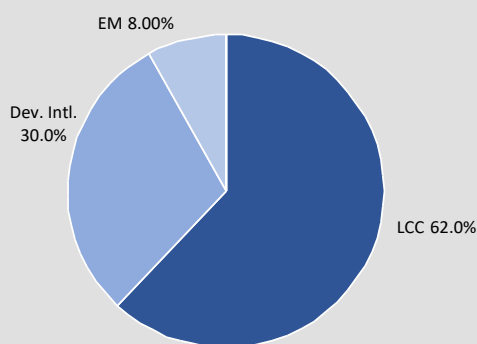

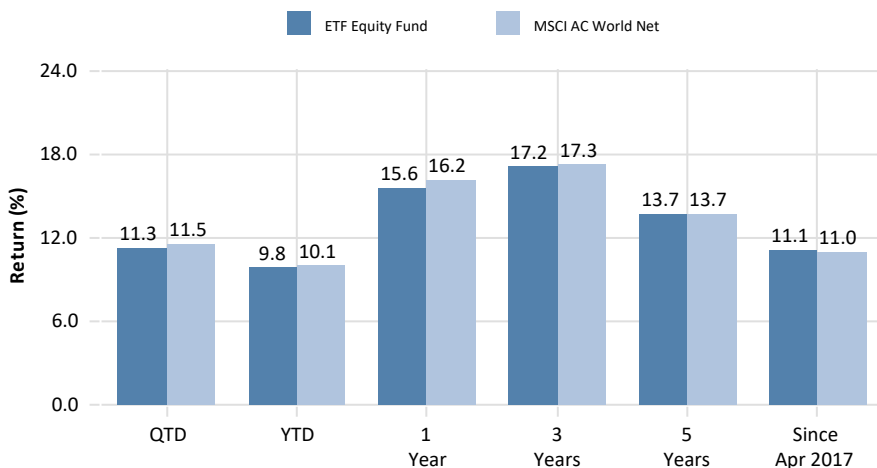

Target Asset Allocation

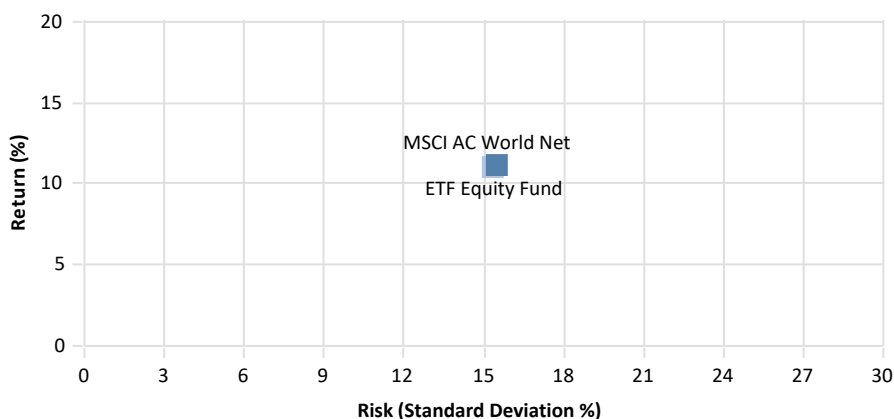

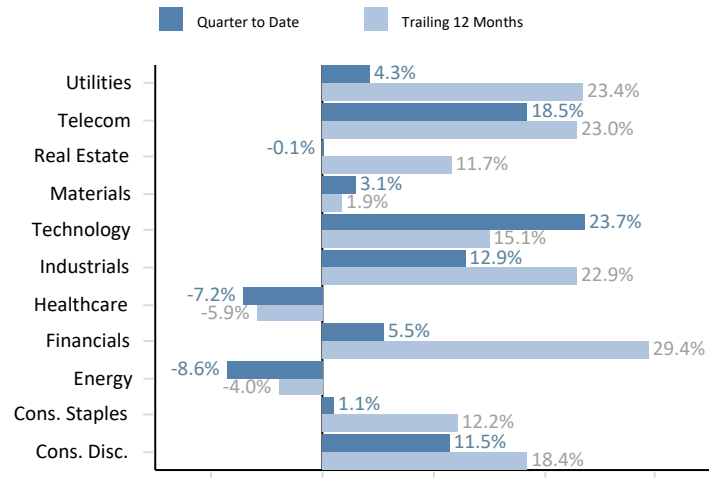

Market Commentary

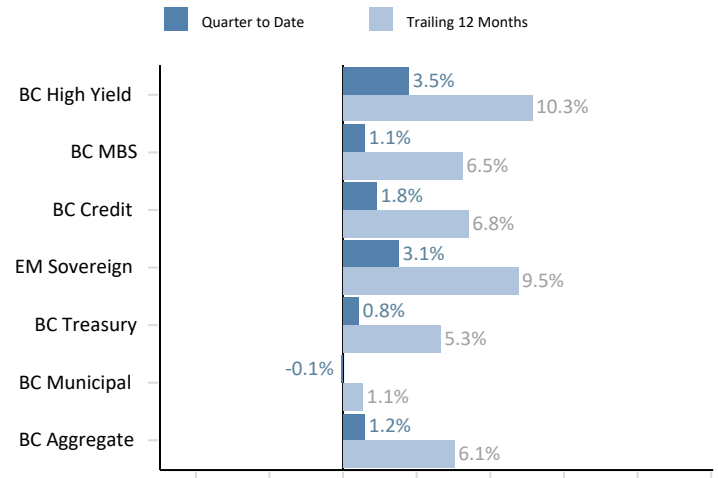
The second quarter of 2025 brought positive total returns of 10.9% for the S&P 500, while eight of its 11 sectors posted gains quarter-over-quarter. US equities recovered from Liberation Day losses, with the S&P 500 reaching new all-time highs amid the de-escalation of global tensions, hard data resilience, and expectations for easing monetary policy. The Federal Reserve opted to keep the federal funds rate unchanged in its May and June FOMC meetings. The FOMC maintained a wait-and-see stance, as potentially inflationary trade and fiscal policies could offset cooling inflation data. Throughout the first quarter, the US dollar decreased by about 7.0% and gold prices increased about 5.7%, following a nearly 20% rally last quarter.

Inflation data was moderately lower throughout the second quarter, measuring at 2.4% in May, likely preserving the low likelihood of multiple Federal Reserve rate cuts in 2025. The Fed continues to weigh its dual mandate of keeping inflation low and maintaining strength in the job market while being sure to not overheat the economy by cutting rates too rapidly. MS & Co.'s Economics team believes there will now be no rate cuts in 2025, with cuts resuming in March 2026.

Peer Group Ranking Methodology

A percentile rank denotes the value of a product in which a certain percent of observations fall within a peer group. The range of percentile rankings is between 1 and 100, where 1 represents a high statistical value and 100 represents a low statistical value.

The 30th percentile, for example, is the value in which 30% of the highest observations may be found, the 65th percentile is the value in which 65% of the highest observations may be found, and so on.

Percentile rankings are calculated based on a normalized distribution ranging from 1 to 100 for all products in each peer group, where a ranking of 1 denotes a high statistical value and a ranking of 100 denotes a low statistical value. It is important to note that the same ranking methodology applies to all statistics, implying

that a ranking of 1 will always mean highest value across all statistics.

For example, consider a risk/return assessment using standard deviation as a measure of risk. A percentile ranking equal to 1 for return denotes highest return, whereas a percentile ranking of 1 for standard deviation denotes highest risk among peers.
